- Completion of the Stronger Together Community Survey - 1 of 5 \$100 Coles Gift Cards
- Completion of the Community Conversation Toolkit - 1 of 2 \$250 Visa Gift Cards

With the following Terms and Conditions

- Only operators of a community organisation within the Sunshine Coast region are eligible to win the \$250 Visa Gift Card. The prize will go to the organisation or entity who owns and/or manages the community venue (not an individual).
- The Visa Gift Cards must be spent by the organisation on products that will be beneficial to the organisation.

- By submitting a survey or a conversation toolkit and including your information, you have entered a competition to win the specified prize on offer.
- Personal information collected by council in the survey or community conversation toolkit is used only for the purposes specified and is not passed on to third parties, unless specifically stipulated in these Terms and Conditions.
- Council is authorised to collect this information in accordance with the *Local Government Act 2009* and other local government Acts. Your personal information is only accessed by persons authorised to do so in compliance with the *Information Privacy Act 2009*. Your personal information is dealt with in accordance with council's Privacy Policy.
- By submitting a survey or community conversation toolkit and including your information, you have entered into a competition to win the specified prize on offer.
- A submission is evidence of the entrants' consent to these Terms and Conditions.
